

Manor FFA Chapter Show

- Show Date: January 30, 2021 - Manor ISD Project Facility (Ag. Barn)
- This show is intended to replace the opportunity for Manor FFA members to show at the Travis County Youth Show which was cancelled due to COVID-19. **Only those students and projects that were entered in TCYS as Manor FFA members may show in the Manor FFA Chapter Show.**
- Social-distancing protocols will be enforced and face masks will be required. We will check temperatures as students and parents enter the arena area.
- All attendees MUST complete the [Barn Check In Form](#) prior to entry. (Available on the Manor FFA website.)
- We cannot guarantee that we will be able to host this show, but we will make every effort to move forward as scheduled. We will follow all administrative recommendations.
- The show will consist of:
 - ◆ Heifers
 - ◆ Lambs
 - ◆ Poultry (cockerels and pullets)
 - ◆ Rabbits
 - ◆ Steers
 - ◆ Swine
- One group of exhibitors and parents will need to clear the arena area prior to the next group showing. We must limit contact and this must be done in a timely manner. Only students will be allowed to social distance inside of the barn to prep animals for show.
- Only exhibitors and their parents are allowed to be present for the show. No additional siblings, family members, or friends will be eligible. There is a maximum of **2 parents/guardians per family.**

- All TCYS entry fees will be returned to the exhibitors upon receiving them from TCYS. There will be no entry fee for the Manor FFA Chapter Show.
- No pass, no play is in effect. You MUST be passing to show.

Schedule

Heifer

1. Each exhibitor may enter only those heifers entered in TCYS.
2. Heifers participating in the open show must follow state validated rules per the TCYS General Livestock Rules.
3. Original registration papers must be in the exhibitor's name by November 1, 2020.
4. TCCA recognized breeds are eligible to show. For original registration papers must indicate the animal meets breed requirements. No entries registered under ranch names or in partnerships will be accepted.
5. All exhibits are subject to Texas Animal Health Commission rules.
6. No additional or artificial hair, twine or other foreign material may be used in grooming of breeding heifers. Show will be a blow-and-go event.

CLASS:

1. Heifers

Lambs

1. Each exhibitor may enter only those lambs entered in TCYS.
2. Wether and ewe lambs will be eligible to be shown.
3. There will be no weight limit for the show.
4. Lambs will be classed by weight.
5. The advisors will determine that all lambs are uniformly slick shorn from the knee joint and hock joint before the time of weigh-in.
6. No painting, powdering, artificial coloring, or adhesives will be allowed.
7. All market lambs must follow the TCYS Eligibility of Animals Rule #3 and Livestock Validation Rule #11. Lambs must have the state validation tag and tattoo in the ear at the time of arrival on the grounds.
8. Administration of medications to all market animals must follow TCYS Junior Livestock Rule #7.

CLASS:

1. Lamb

Poultry

1. The exhibitor may show one cockerel and one pullet as entered in TCYS.
2. Each exhibitor will be tagged and assigned a unique identification wing band numbers for their fryer order from which they must select their fryer entry.
3. The birds must have their original and un-tampered wing bands at the time of entry.
4. At check-in, the judge will do a preliminary judging and will sift for sex, wing bands, parasites, fitness, and quality.
5. There will be no weight limits.
6. Administration of medications to all market animals must follow TCYS Junior Livestock Rule #7.
7. Sifted birds will be released to the exhibitor and removed from the Show Grounds immediately.
8. Show birds will be released to the exhibitor and removed from the Show Grounds immediately following the show.

CLASS:

1. Cockerel Class
2. Pullet Class

Rabbits

1. Rabbits will be delivered to the arena in a box that will be provided by the show. No identification materials can be on the box (including names, numbers, etc.) Rabbits will only be identified by their tattoo numbers. Exhibitors will not handle the rabbits in the arena.
2. Each Exhibitor may enter one (1) rabbit fryer as entered in TCYS.
3. Single fryer rabbit definition: One single animal. There will be no weight limit.
4. VALIDATION/TATTOOS: Exhibitors must have ownership and possession of meat rabbit pens prior to the validation date.
5. No substitutions of rabbits will be allowed after the rabbits enter the exhibition area.
6. Administration of medications to all market animals must follow TCYS Junior Livestock Rule #7.
7. All sifted rabbits will be released back to the exhibitor and must be removed from the Show Grounds immediately.
8. All show rabbits will be released back to the exhibitor and must be removed from the Show Grounds immediately following the show.

CLASS:

1. Single Fryers

Steer

1. Each exhibitor may enter only those steers entered in TCYS.
2. There will be no weight limit.
3. No change of the major color pattern or dyeing will be allowed, with the exception of dressing on hooves and scurs. Any grooming material that allows color to come off any steer will not be allowed at the Show.
4. At weigh-in, no other equipment except a rope halter and/or nose ring can be attached to the animal.
5. All steers will be clipped to have no more than one-quarter inch of hair on any part of the animal's body. The only exception will be the switch of the tail. The switch may be ratted and balled or may be bobbed off.
6. No steer will be allowed to weigh-in or compete which has any oils, glues or other foreign material present.
7. All market steers must follow the TCYS Eligibility of Animals Rule #3 and Livestock Validation Rule #11. Steers must have the state validation tag and tattoo in the ear at the time of arrival on the grounds.
8. Administration of medications to all market animals must follow TCYS Junior Livestock Rule #7.

CLASS:

1. Steers

Swine

1. Each exhibitor may enter those swine entered in TCYS.
2. Barrows and/or Gilts may be entered for competition.
3. There will be no weight limit for the show.
4. Swine will be classed based on weight.
5. The use of talc, oils or any foreign material will not be permitted. No drenching methods can be used.
6. All market swine must follow the TCYS Eligibility of Animals Rule #3 and Livestock Validation Rule #11. Swine must have the state validation tag in the ear at the time of arrival on the grounds. Any swine arriving at the Show Grounds without the appropriate ear tag and notches will be subject to disqualification.
7. Administration of medications to all market animals must follow TCYS Junior Livestock Rule #7.

CLASSES:

1. Class 1 Pigs
2. Class 2 Pigs
3. Class 3 Pigs
4. Class 4 Pigs

COVID 19 Policy:

1. All CDC guidelines will be strictly enforced in the barn for this event. District liability waiver and Social Distancing contract must be signed and submitted electronically prior to the show date. **No one will be permitted in the Ag Barn or Show Arena without a clean mask!** All social distancing measures will be strictly enforced. Forms are available on the [Manor FFA website](#).
2. Please stay clear of all surfaces in the AG Show Barn Arena area. Only parents of students showing at any point during the show, will be permitted in the arena area to help mitigate the spread of the virus.
3. **Ag Project Facility COVID19 Check-in Form must be completed and temperature checks upon entering the barn or arena will be mandatory.** Anyone with a fever of 100 F or above or any of the COVID-19 symptoms/exposure **will not** be allowed in the barn or arena and referred to the nurse (in the case of symptoms or exposure, nurses will be contacted with referrals).
4. Other guests must remain in vehicles or outside the arena socially distanced, until their student is ready to show. **Only 2 parents/guardians per family will be allowed.**
5. In addition to pen sanitation, students will be responsible to continue sanitizing all touched areas during feeding/exercising at the Ag Barn as well as after showing their species.
